The letter states "Per our telephone conversation, you brought to the board's attention that you are planning to build an extension onto your existing barn which would encroach upon the easement. We wish to inform you that this would not be allowed according to our bylaws and covenants. We wanted to make sure you are fully aware that this current plan would not be approved by the Board." This letter is dated July 9, 2010. Motion was made to send the letter to RC. Motion was seconded and carried.

Al Broccolini (1124 Belgian Trail) came to the meeting asking if the board has any authority over the bridle trail. Since the homeowner actually owns the easement on the property, the only control the board has is to insure that no one can encroach onto that easement.
